**RESOLUTION CONCERNING TCEQ PROPOSED AIR QUALITY PERMIT NUMBER 147392L001,
WHICH WOULD AUTHORIZE CONSTRUCTION OF A PORTABLE ROCK CRUSHING PLANT
(QUARRY) IN COMAL ISD**

WHEREAS, Vulcan Construction Materials, LLC has applied to the Texas Commission on Environmental Quality (TCEQ) for issuance of air quality permit number 147392L001 on the former White Ranch, whose northeast corner is the intersection of Highway 46 and Farm-to-Market Road 3009, and extending from that point nearly three miles to the southwest; and

WHEREAS, the property designated as the site of the proposed quarry is entirely located within the boundaries of CISD; and

WHEREAS, Comal ISD has received numerous inquiries related to Vulcan Construction Materials' proposal to establish rock crushing quarry operations at a site near Highway 46 and FM 3009, Comal County, Texas; and

WHEREAS, the residents and surrounding communities are concerned about the potential negative impacts on the quality of life in the community and the environment, especially the air and water quality in the area; and

WHEREAS, the residents and surrounding communities are concerned about the negative impact and disruption created by the increased heavy truck traffic, as well as the noise, exhaust emissions, and dust pollution created near the traffic corridors used in the rock crushing operations; and

WHEREAS, the residents and surrounding communities are concerned about the deterioration and destruction of infrastructure caused by the overburdening of the roadways from increased heavy truck traffic; and


WHEREAS, Title 30, Section 55.203 of the Texas Administrative Code states that governmental entities such as an independent school district with "interest in the issues relevant to the application" may be accepted as an "affected person" in a TCEQ contested case hearing, and numerous school districts have previously requested and been accepted as "affected person" in such hearings;

NOW, THEREFORE, BE IT RESOLVED by the School Board of Comal Independent School District:

1. Comal ISD supports the concerns of its local residents and neighbors in the proposed development and the location of the Vulcan Rock Crushing Quarry Operations in the Comal County community.
2. The Comal ISD School Board hereby request a contested case hearing on air quality permit number 147392L001, and that Comal Independent School District be considered an "affected person," and supply to TCEQ all required information, according to Title 30, Chapter 55, Subchapter F of the Texas Administrative Code.


