#### Important Dates and Activities You Need to Engage In

**December 3rd** @ **5 p.m**. The final filing date for all those persons who were NOT recommended for 'Affected Party' (AP) status by TCEQ, the Applicant and/or OPIC (hereby named 'the parties'). In filing your 'reply brief' you are afforded to opportunity to reply to any arguments filed by the parties.

#### Who should file a 'reply brief'?

Any hearing requestor\* who was not recommended for 'AP status. (\*NOTE: You may only file a 'reply brief' if you initially filed a CCH/AP request on or before 10/15/18. If you did not file a claim at that time, then you cannot file a CCH/AP request now. If you do not recall whether you filed a claim or not, review this <a href="TCEQ document">TCEQ document</a> for your name. If you name is NOT in the TCEQ document, then you CANNOT file a CCH/AP request now)

#### How do I know if I was or was NOT recommended for 'AP' status?

Review pages 4 and 5. If your name appears on one, two or all the parties' list, then you are recommended by that party to be an 'AP'

#### What if my name is only on one or two but not all three lists?

You are encouraged to file a 'reply brief' to the parties who did not recommend you for 'AP' status.

### What are the reason(s) why someone would be recommended vs not recommended for 'AP" status by a party?

The primary reason portrayed by all parties is the application of "arbitrary" radius limits of the person's homestead to the crusher which is the only permitted facility. There is no law, code or scientific data for such decisions, but rather they are a "matter of custom". Each parties' arbitrary radius' selected are:

- TCEQ arbitrary 1-mile radius
- The Applicant arbitrary 1-mile radius
- OPIC arbitrary 2 mile radius

Other reasons may be cited by each party. The TCEQ document is the most comprehensive as to other issues considered. It is recommended that you review the issues shown under your name so that you may file a more comprehensive 'reply brief'. Get TCEQ document <a href="here.">here.</a>

#### If my homestead/business is outside the arbitrary radius limit, what do I do? Say?

If you were not recommended for "AP" status due to your location exceeding the arbitrary radius limitations, focus on qualifying that your distance SHOULD NOT be a preemptive strike!

We have prepared a 'template' for all hearing requestors to follow, with the first issue to address being 'proximity' to the crusher. Follow the instructions on the template and use our recommended language to assist you in making your claim as to 'why' you should be recommended for 'AP' status.

A single template which is personalized can be used for your 'reply brief' to all the parties.

Also focus on 'bolstering' your original issues\* with detailed personal data, scientific articles, legal data, enhanced personal health history which will be affected by fugitive dust containing crystalline silica at or below PM 2.5. If you don't know what 'issues' were recognized by the TCEQ, look at this <u>document</u>. Find your name and under your name, the 'issues' recognized will be listed. (\*NOTE: You cannot raise new issues to bolster you claim. If you do so, TCEQ will not acknowledge them.)

### What do I do if my name is listed on at least one of the parties' lists as being recommended for 'AP' status?

- If you were recommended for 'AP' status by all three parties, you do not need to file a reply brief.
- If you were recommended for 'AP' status by only one and/or two of the three parties, you are encouraged to file an 'reply brief' with the parties who did not recommend you for 'AP' status.

### How do I file by reply brief? Are there other things I must do to guarantee my 'reply brief' is accepted?

The deadline for filing is 12/3/18 @ 5 p.m. That means anything mailed must be 'date stamped' as received on this date. A postmark date of 12/3/18 will not be accepted. Plan on mailing anything no later than Thursday, 11/29/18.
