SUBMITTING COMMENTS

- Submit comments on your own behalf
- Keep your comments specific to the draft wastewater permit. Comments about the development, developer, water supply, etc. will not be relevant or considered.

Request a contested hearing:

- Include all information noted in the next box
- Be sure to include how you are personally affected (different than the general public)

TCEQ CONSIDERATIONS WHEN DETERMINING IF A REQUESTOR IS AN AFFECTED PERSON:

- THE RELATIONSHIP BETWEEN THE CLAIMED INTEREST AND PROPOSED ACTIVITY
- IMPACT ON THE HEALTH, SAFETY AND/OR USE OF PROPERTY OF THE PERSON CLAIMING AN INTEREST BY THE PROPOSED ACTIVITY
- IMPACT ON THE AFFECTED PERSON'S USE OF A NATURAL RESOURCE
- IS THE CLAIMED INTEREST PROTECTED BY LAW?
- DISTANCE RESTRICTIONS OR OTHER LIMITATIONS IN THE LAW ON THE AFFECTED INTEREST

REQUIRED INFO FOR CONTESTED CASE HEARING REQUESTS

1. The requestor's name, physical address, and daytime phone number
2. The permit number and permit applicant's name (or facility name) - **#WQ0016211001**
3. A statement clearly requesting a contested case hearing
4. The location of the requestor's home, business or property that is affected and its distance from the proposed facility
5. A detailed explanation of how the requestor qualifies as an affected person (see the box to the left)
6. Any relevant factual evidence, such as the information in the application, photos, complaint logs, videos, or expert affidavits
7. A list of the disputed factual issues that the requestor would like to raise as part of a contested case hearing

Be sure to reference #WQ0016211001 in your request for a contested case hearing
